The Fu-Chest™ will be an all wood product, fully assembled and Made in the United States. The cabinet will be based on the Cosmopolitan design and available in Twin or Full Size, and a selection of standard or custom finishes.

We can customize the Fu-Chest™ to meet the needs of stocking dealers purchasing more than 100 units per year. This may include exclusive finishes, hardware and/or mattresses not otherwise available to others. Because the Fu-Chest™ is now Made in the U.S.A., specialized or exclusive requirements can be easily met.

**Drop Ship Policy.** Homeplace Group Inc. will drop ship direct to your customers for additional Drop Ship Fee of \$10. No minimum order is required. The Fu-Chests™ are fully assembled and can ship via in-home delivery service to your customer. We are not responsible for shipping charges to your customer; this would be your responsibility.

**The mattress is sold separately.** The Fu-Chest takes an 8" standard full size futon mattress, optional or exclusive types and models are available, please inquire.

**A credit application** must be on file before Homeplace Group will begin to drop ship.

**A copy of your resale certificate** or your resale number is required before Homeplace Group will begin to drop ship.

**Payment Terms.** We accept company checks, credit cards and purchase orders for established accounts. All invoices must be paid upon receipt; if timely payments are not made, Homeplace Group will hold current orders until payment is made and future orders will then be on a "Cash before Shipping" basis. Credit card payments for quantity or discounted orders are subject to a 2.5% surcharge.

Homeplace Group can prepay and handle the delivery charges for drop ship customers, but will apply a \$20 handling charge for this service.

**Shipping Damage** It is the responsibility of the consignee to note any damages to the shipment on their delivery receipt. Without such notations, carriers will not honor damage claims. Please advise consumers/consignees to note all damages and the condition of the cartons on their copy and the driver's copy of the delivery receipt.

**Problem Shipments** Homeplace Group, Inc. drop ships at the request of our drop ship customers and cannot assume the risk of their business. From time to time consumers will order the wrong item, have buyer’s remorse or have some issue with the delivery. We will work with our drop ship customers to rectify the situation, but all costs associated with the delivery and restocking of undamaged merchandise is the responsibility of the drop ship customer. There is a 15% restocking fee. If Homeplace Group, Inc. ships the wrong item or ships defective merchandise, we will assume the cost to pick up and reship the correct item.

**Storage Fees** All storage fees incurred by consumers/consignees will be passed along to the drop ship customer. Homeplace Group recommends getting alternate phone numbers such as a cell phone and e-mail address from customers so that consumers/consignees can be reached during business hours. Also, making the consumer/-consignee aware of the estimated delivery date and giving them the delivery service center number as well as the PRO number helps to facilitate delivery.

**Restocking:** Homeplace Group will accept undamaged returned merchandise. However, all freight to and from the “ship to” location is the responsibility of the catalog/on-line merchant. Mattresses that have been opened may not be returned. A 15% restocking fee will be charged on each item to be restocked. Merchandise that is returned damaged cannot be resold and will be invoiced.

**Replacement parts** – Homeplace Group will ship replacement parts for damaged or defective product if possible. Sometimes it is more cost effective to ship a new product because of the size and weight of the parts. Additionally, the size of the parts makes shipping expensive and prone to damage if taken out of the original package and not palletized.

The cost of the part and the cost of shipping those parts is the responsibility of the drop ship customer. In the case of defective merchandise, Homeplace Group will cover the reshipping cost.

A signed copy of this agreement with the first page initialed is required before Homeplace Group, Inc. will begin a drop ship program.
